



Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 28/03/2014 considered Council assessor report (May, 2013) on the physical and other teaching facilities available at Maharashtra Institute of Medical Education & Research, Pune for the award of MD(Social & Preventive Medicine / Community Medicine) qualification under Maharashtra University of Health Sciences, Nashik. The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Committee considered the assessment report (May, 2013) and decided to recommend that MD(Social & Preventive Medicine / Community Medicine) qualification for 2(Two) seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Maharashtra Institute of Medical Education & Research, Pune be recognized and included in the 1st Schedule to the L.M.C. Act, 1956.

The Council further approved the following recommendation of the Postgraduate Committee as amended:-

"The Postgraduate Committee further decided that the attention of the institute be drawn to Sections 6 (4), 6 (5) & 6 (6) of Postgraduate Medical Education Regulations, 2000, as amended by amendment notification Postgraduate Medical Education (Amendment) Regulations, 2009 Part-II" dt. 21/07/2009 and act appropriately at appropriate time which read as under:

6....

(4) The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed. Further approved the following recommendation of the Postgraduate Committee as amended:

(5) The procedure for Renewal of recognition shall be same as applicable for the Award recognition.
