 - ii. Required teaching staff as per Teacher: Student ratio prescribed by Central Council / Commission / University norms is fulfilled.
 - iii. Admission of students is subject to availability of PG recognized teachers.
 - iv. It is mandatory to fulfil the prescribed minimum standard requirements for Undergraduate training as per the norms of Central Council and obtain Continuation of Affiliation for the UG Course also.
 - v. For those UG/PG qualifications that are not yet recognized by the Central Government, it shall be mandatory for the College to apply to the Central Council / Commission through Central Government and ensure that "Permitted" / "Not Recognized" qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year and no students shall be admitted in such courses.
