Regulations for Preventions Against Ragging:

 Ragging is banned in any educational institute according to Medical Council of India (Prevention and Prohibition of Ragging in Medical Colleges / Institutions) Regulations 2009.

2) According to this regulation Ragging includes the following

Any conduct whether by words spoken or written or by an act which has the effect of harassing, teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher of a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

3) Punishable ingredients of Ragging include:

Abetment to ragging, Criminal conspiracy to rag, Unlawful assembly and rioting while ragging, Public nuisance created during ragging, Violation of decency and morals through ragging, Injury to body, causing hurt or grievous hurt, Wrongful restraint, Wrongful confinement, Use of criminal force, Assault as well as sexual offences or even unnatural offences, Extortion, Criminal trespass, Offences against property, Criminal intimidation, Attempts to commit any or all of the above mentioned offences against the victim(s), Physical of psychological humiliation, All other offences following from the definition of "Ragging".

- 4) Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:
 - 4.1 Suspension from attending classes and academic privileges.
 - 4.2 Withholding / withdrawing scholarship / fellowship and other benefits.
 - 4.3 Debarring from appearing in any test / examination or other evaluation Process.
 - 4.4 Withholding results.
 - 4.5 Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
 - 4.6 Suspension / expulsion from the hostel .
 - 4.7 Cancellation of admission.
 - 4.8 Rustication from the institution for period ranging from 1 to 4 semester.
 - 4.9 Expulsion from the institution and consequent debarring from admission the any other institution for a specific period.
 - 4.10 Fine of Rs.25,000/- and Rs.1 Lakh.
 - 4.11 Collective punishment : When the persons committing or abetting the crime of ragging are not identified , the institution shall resort to collective punishment.

• The squad members also make efforts to meet the students at regular intervals.

 The antiragging commitment of the institute is made further viible to the students by means of posters displayed on the students notice board and other places. The posters are both in English and Marathi language.
